The PHILIPPINE NATIONAL POLICE, POLICE REGIONAL OFFICE 13 (PNP, PRO 13-CARAGA), pursuant to the following:

- a. Memo from The Director for Comptrollership dated October 27, 2015, with subject: Directing PROs to start the Implementation of their Procurement Activities of Infrastructure Projects for 2016.

Intends to apply the sum of Thirty Four Million Two Hundred Five Thousand Two Hundred Forty Three Pesos and Twenty Four Centavos (Php34,205,243.24) being the Approved Budget for the Contract (ABC) to payments under the contract listed below. Bids received in excess of the ABC for the particular project shall be automatically rejected at bid opening.

The PHILIPPINE NATIONAL POLICE, POLICE REGIONAL OFFICE 13 (CARAGA) now invites bids for the Construction of Seven (7) Municipal Police Station Buildings. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines. Interested bidders may obtain further information from PNP, PRO 13 (CARAGA) and inspect the Bidding Documents at the address given below from 8:00AM to 5:00PM (Monday-Friday).

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Php5,000.00.



Bids must be delivered to the address below on or before December 18, 2015 at 2:00PM at the PRO 13 Conference Room, Camp Rodriguez, Butuan City. All bids must be accompanied by a bid security in any of the acceptable forms as in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidders/representatives who choose to attend at the address below. Late bids shall not be accepted.

The PNP, PRO 13 (CARAGA) reserves the right to accept or reject any bid, to annul the bidding process, and to reject bids at any time prior to contract award, without hereby incurring any liability to the affected bidder/bidders.
